# 2026 Consignment Form

## 1. GENERAL CONDITIONS APPLICABLE TO ALL ART

- Artists must be financial members of RQAS Gold Coast.
- Art must be the original work of the member entering the work for exhibition or competition.
- **Artworks must not breach any copyright or liable laws.** The Society will remove any artworks in breach of these laws.
- RQAS retain 25% commission on **all** gallery sales and 15% on Art in the Park sales
- The Artist agrees that images of their artwork may be used by the Gallery for advertising or promotional purposes and to the public taking photographs of any exhibits
- All possible care will be taken with all works. **RQAS accept no responsibility for loss, damage or theft. Artists may arrange their own insurance.**
- The artwork remains the property of the artist until sold. The artist authorises RQAS to sell the artwork as agent for the artist in accordance with the conditions in this form. RQAS is not responsible for issuing tax invoices for sales it makes on behalf of artists. RQAS will promptly inform an artist if a tax invoice is requested by a buyer and will provide details of the relevant sale.
- All amounts specified in this form are inclusive of GST.

## 2. MONTHLY EXHIBITION

- Artworks must be ready for hanging & have artists name, title, the medium, theme or non-theme & price on the back.
- Standard consignment fees are currently \$10 for one painting, \$15 for two.
- Artists must assign for Roster Duty during the exhibition, otherwise \$40 is to be paid 'in lieu'.
- If artists do not attend for their assigned roster without arranging a substitute, their artwork will be removed from the exhibition.
- Exhibiting members must complete "Roster Duty Induction Training" before being able to hang their work.
- Minimum sale price is \$150, any paintings submitted for less will be sold at \$150.
- Artworks must remain with the exhibition for its duration unless sold.
- Artworks will be sold at the price nominated by the artist unless the artist is contacted and agrees to accept a reduced price.
- If sold during the exhibition, the artist is entitled to bring in a replacement artwork of similar size.
- All diptychs & triptychs must be joined together as one piece for hanging.
- **No Giclées or prints** of any kind will be accepted.
- Artworks entered in the monthly exhibition cannot be re-entered for a 3-month period.
- Maximum size of artwork is 450cm total perimeter.
- Any artwork **not collected** 30 days after changeover will be donated to charity.

## 3. SMALL ART

- Size no more than 100cm perimeter including the frame.
- Maximum selling price is \$140 (multiples of \$5).
- Artwork is changed every 3 months.
- Price to hang per painting is \$5 for 3 months.

## 4. GIFT SHOP SPACE

- Price per space is \$15 for 3 months

### SCULPTURE

- Price per plinth is \$15.00 for 3 months per plinth.

### CARDS

- Each card must have a barcode
- 5 Cards permitted at any time and free to display.
